

**PUBLIC NOTICE**

The City of Hawthorne is applying for Disaster Recovery Initiative funding in the amount of one million one hundred sixty-five thousand dollars (\$1,165,000.00) provided by the U.S. Department of Housing and Urban Development (HUD) to assist the State of Florida in recovering from the effects of Hurricane Irma 2017 Storm Events. This funding will be administered by the Florida Department of Economic Opportunity (DEO) and can only be used for selected activities that are directly related to the disaster or for disaster mitigation. Activities that are typically eligible for funding under the Community Development Block Grant (CDBG) Program are eligible projects if no other funding is available to meet the need. Applications are due in DEO no later than August 30, 2019.

The City of Hawthorne intends to submit an application which will include the following activities:
