CERTIFICATE OF LAND DEVELOPMENT REGULATION COMPLIANCE

1. Date, north arrow, and graphic scale
2. Area and dimensions of site;
3. Location of all property lines, existing right-of-way approaches
4. Location and dimensions of all existing and proposed parking areas and loading areas;
5. Location, size, and design of proposed landscaped areas (including existing trees and required landscaped buffer areas);
6. Structures and major features fully dimensioned including setbacks, distances between structures, floor area, width of driveways, parking spaces, property or lot lines and percent of property covered by structures; and
